QANTM continues to progress in this area. Unconscious bias training has now been completed across the whole group and the DCC D & I Committee's presence continues to grow. The group has also recently conducted workplace behaviour training. This training incorporated sexual harassment training including sensitivity around people diversity. QANTM Intellectual Property Limited is the parent entity of two existing intellectual property firms. The two established firms which comprise the QANTM group are Davies Collison Cave and FPA Patent Attorneys. Both firms continue to operate separately to one another and have different sets of company policies. The parental leave policies of FPA Patent Attorneys and Davies Collison Cave are summarised below:

FPA Patent Attorneys:

- All full time and part time permanent employees with one year or more of continuous services immediately before the expected date of birth (or arrival in the case of adoption) are eligible for parental leave. Casual employees who work regularly and systematically for at least 12 months which is expected to continue are also eligible.
- 18 consecutive weeks of paid parental leave to all staff, inclusive of any eligible government benefit. There is an additional 34 weeks of unpaid parental leave available.
- There are up to ten days of paid leave for employees to 'keep in touch' by attending work for training/seminars. Childcare is also paid to attend these training days if no other care is available to the primary carer eg by another parent/ family member.
- Employees can apply to extend their unpaid parental leave period for a further 12 months, to a maximum of 24 months. If they do not return to work after parental leave for a minimum of six months, they may be required to repay the component of firm-funded component of paid parental leave.

During this reporting period there was a request for an employee to receive 6 months paid parental leave immediately after the birth mother completes 6 months parental leave. FPA undertook some research and decided to award paid parental leave to the non-primary carer when they subsequently took on the role of

primary carer within the first 12 months. this means that the family has access to 2 periods of paid parental leave which is beneficial tot hat family.

Davies Collison Cave:

- Parental leave benefits paid are in addition to entitlements outlined in the Fair Work Act and Paid Parental Leave Act which provide for paid parental leave under government schemes.
- A minimum of two years' continuous service, prior to the birth or adoption of a child, is required.
- The birth mother must have a bona fide intention of returning to the Company within 12 months of taking leave.

- The paid leave is based on normal salary (full time or part time hours).

- Parental leave is paid out as follows:
